# 200+ Club

## WHO ARE THE SWANS?

An organisation formed to assist disabled and/or handicapped people to participate in leisure and sporting activities and enjoy them to the same extent as more fortunate able bodied folk.

## WHY A 200+ CLUB?

It costs money to provide a clubroom and sporting facilities — for example, over £200 per week for a clubroom and the use of the ToneZone and swimming pool and transport for our members.

Income is from various sources, not the least of which are the fundraising activities of the disabled people themselves.

In order to provide a regular flow of money to contribute to the club facilities, you are invited to join the "200+ Club" which has been formed.

#### **HOW DOES IT WORK?**

Members are invited to contribute £1 per month (more if they wish) of which 50% goes to the Swans charity with the other 50% being returned to the members as prizes drawn monthly.

#### **PRIZES**

It is intended to have at least 200 members, and the prizes for this number are shown below, together with those for 150 and 125 members. Whatever the membership, 50% of all contributions are returned as prizes.

### **RULES OF THE SWANS 200+ CLUB**

- Only members of the Leatherhead Swans are entitled to participate in the draw (see Rule 2).
- 2. The grades of membership of the Leatherhead Swans are i) Active Members, ii) Associate Members. The only right attaching to Associate Members is eligibility to participate in the Swans 200 Club.
- 3. Subscriptions for each share shall be £12 per annum, payable by banker's order, cheque or cash
- Any member whose subscriptions falls into arrears shall automatically forfeit the right to be included in any subsequent draw until the arrears are paid.
- 5. The draw has run from April 1984.
- 6. Every share purchased will, subject to Rule 4, participate in the monthly prize draw. Subscriptions in any month will be eligible for the draw on the first Monday of the following month.
- 7. All subscribers shall be entitled to attend the draws.
- 8. On no account will the promoters pay any prize money to any person other than the purchaser of the winning share.
- 9. No subscription money will be refunded.
- if there is insufficient interest to continue the draw, the remaining funds available for prizes will be distributed by way of a final draw.
- 11. The promoter of the draw is D.G. Lewis, 245 Lower Road, Great Bookham, Surrey, KT23 4DN who has been duly appointed by the Committee of the Leatherhead Swans.
- 12. In the event of any dispute, the decision of the promoter and the Committee of the Leatherhead Swans will be final and binding.
- 13. 50% of all subscriptions will be returned to members as prizes. The other 50% less expenses will go to the funds of the Leatherhead Swans.
- 14. Prizes will be distributed to prize winners monthly.
- 15. The competition is conducted under the provision of the Betting, Gaming and Lotteries Act 1963 (section 44).
